Entry Information

Test your skill in Aspen's best snow sculpture event of the year! Carve an 8'x8'x8' cube of snow in 48 hours on the Aspen pedestrian mall. Anderson Ranch Arts Center is seeking submissions from young and old, families and businesses, and artists and amateurs. Everyone is invited to participate. It only takes a good idea, a love of snow, and a few pairs of mittens.

Please read the rules carefully. Prize money will be withheld if you do not adhere to these regulations.

Each team will receive a \$200 Participation Stipend to help support team expenses. The team leader will receive a check upon completion of their sculpture.

NOTIFICATION: All applicants will be notified of selection decision by **Wednesday, December 14.**

RULES MEETING AND BLOCK LOCATIONS: The drawing of block locations will occur during a team/artist meeting Tuesday, January 10, at Anderson Ranch Arts Center @ 5:30pm

SCULPTING: Starts on pedestrian mall at 4pm, Thursday, January 12. Ends at 4pm, Saturday, January 14.

JUDGING & AWARDS: Judging is at 5pm, Saturday, January 14, and the awards announcements will be at 6pm at WinterFest.

INSTRUCTIONS

1) Assemble and name your team of no more than six people.

Appoint a contact person for the team, and completely fill out the attached entry form. All participants must also sign the attached waiver form. (Sculptors under the age of 18 must have a parent or guardian's signature).

IMPORTANT: Read the competition rules.

2) Create a sketch of your sculpture on one side of an 8 1/2" x 11" paper, and attach it to the entry form. Label it with your Team Name (sculptor names will remain anonymous during selection). Pen and Sharpie only please.

3) Submit your completed entry form, sketch, and waiver by Friday, December 9, 2011.

SELECTION & JUDGING

Six teams will be selected.

The Selection Committee will evaluate sketches based on: overall creativity, design concept, proposed use of snow and any connection to the theme stated above.

WINTERSCULPT COMPETITION RULES

***All teams and sculptors are required to attend a **meeting Tuesday, January 10 at 5:30pm** to go over rules and draw block locations. ***

Design Criteria:

- Utilize the 8' x 8' x 8' cube of snow with completed sculpture not exceeding these dimensions by more than 2 feet in any direction (i.e. the largest dimensions a sculpture could be is 12' Length x 12' Width x 10' Height).
- Sculptors must take into account the structural integrity of the snow in terms of thickness, span, and public safety.
- Sculptures must consist of snow only. Icicles, snow coloring, attachments, or structural reinforcements are prohibited.
- All sides of the snow block should be sculpted.

Restrictions:

- The sculpture may not represent or incorporate a commercial product, logo, or advertisement, nor can it reproduce the name of any organization or its logo.
- The sculpture shall not express political views, bigotry, or sexual content.
- Teams must provide their own tools. (Electricity and water will not be provided).
- No additional lighting is allowed on the site for the final presentation.
- Due to safety precautions, **NO HOLLOWED-OUT** sculpture designs or **CLIMBABLE** or **WALK-THROUGH** features will be accepted. If the final sculpture incorporates any of these elements, the team will be disqualified.
- Alcoholic beverages and/or controlled substances are prohibited.
- Teams must move excess snow to designated areas.
- Automobile access to the mall is restricted to drop-off and pick-up of tools.

Judging:

- The judging will take place on Saturday, January 14 between, 5 and 6pm.
- Teams must follow the above contest rules as outlined in order for the sculpture to qualify for final judging.
- Judges will evaluate based on the following:
 - Overall creativity and design concept
 - Technical execution and use of snow as a medium
 - Compliance with the criteria and rules listed above
- Judges reserve the right to disqualify a team and withhold prize money if sculpture is not completed or the rules are not followed.

General Rules and Other Information:

- This competition takes place on city-owned land and contestants participate at their own risk.
- Signage will be provided by Anderson Ranch Arts Center and will be displayed prior to sculpting.
- Wintersköl and Anderson Ranch Arts Center will not be responsible for any personal injury or for loss of or damage to any personal property.
- Personal belongings should be secured at all times. Please leave valuables at home or in your car.
- Wintersköl and Anderson Ranch Arts Center reserve the right to acquire visual documentation for promotional and informational purposes without indemnity to the participants.
